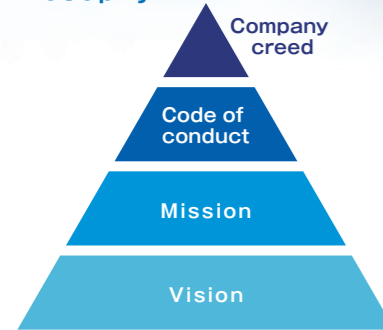


# Chemicals for the Future

JCI has achieved the goal of "100% Renewable Energy" for electricity used by JCI headquarters as of April 1, 2022. Thanks to this, we have managed to cut the amount of carbon dioxide emitted by the entire JCI headquarters by 80%. Furthermore, JCI aims to "achieve zero net carbon dioxide emissions" at its factories. In addition, in its overseas activities, JCI will make efforts toward "net zero carbon emissions from its factories worldwide."

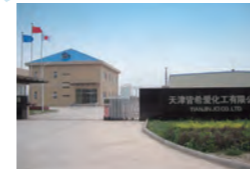
